## Program Description

Developed and piloted at elementary schools in Chicago and in District U-46 (Elgin, Illinois and surrounding communities), **VOICE** incorporates conflict resolution, law-related education, and service learning to help students develop a deeper understanding of the U.S. Constitution and our system of government. Since 1996 **VOICE** has supplemented 4<sup>th</sup> and 5<sup>th</sup> grade social studies and reinforced reading and math skills. In 2000, using the **VOICE** framework, the Constitutional Rights Foundation Chicago created **Primary VOICE** for 2<sup>nd</sup> and 3<sup>rd</sup> grades, using literature in conjunction with interactive lessons.

The **VOICE** and **Primary VOICE** models involve teams of attorneys; field experiences; interactive lessons which emphasize critical thinking, effective communication, and peaceful resolution of conflict; and projects which contribute to the well-being of the school and highlight quality student work.

In Illinois, the **VOICE** and **Primary VOICE** curriculum meets 13 of the Learning Standards of the Illinois State Board of Education. Teachers will be given time to align the **VOICE** curriculum with their own state standards.

## Program Benefits

A two year independent evaluation of the **VOICE** program showed that participating students:

- learned more about the U.S. Constitution and government than non-participating students, and improved their Iowa Test of Basic Skills Scores,
- had a better understanding of how to help others solve problems, and had fewer problems with discipline and fighting.

Teachers participating in a **Primary VOICE** professional development project reported:

- lessons address Illinois State Learning Standards for both social studies and language arts.
- lessons create powerful experiences for students that enhance literacy skills including comprehension, oral and written communication, vocabulary.

## Participant Benefits

- Lodging (sharing a room) and per diem from August 4-6. (Residents of the Chicago metropolitan area are not eligible for lodging but will receive a complementary lunch daily).
- Coach airfare to and from Chicago up to \$400 round trip.
- Lessons for classroom use.
- A \$150 stipend after the successful completion of the institute.
- \$25 per lesson or 1 CPDU per lesson for teachers who complete a "teacher reflection" provided by CRFC entitled "Teacher Reflections." (suggested 4 lessons)
- Chicago area teachers attend the Illinois LRE Education Conference on October 24 for a follow-up seminar. Teachers from out of state will attend a follow-up seminar scheduled by their state coordinator in the fall of 2003.
- Illinois teachers can receive up to 30 contact hours for Continuing Professional Development Units (CPDU's) which includes the summer institute and follow-up session.

## Application Procedure

- Complete the Applicant Information and Agreement Forms.
- Have the Application Agreement co-signed by your principal.
- Have the Application Agreement co-signed by state LRE coordinator (applicants outside Illinois).
- Include Registration Fee of \$100 payable to the Constitutional Rights Foundation Chicago.
